License is valid for ninety days from date issued and is not transferrable. Renewal fee is \$100.00 if renewal is filed before license expires. The transient vendor license number, state sales tax number, and a statement that vendor is required to give purchasers a receipt which includes sales tax, must be displayed in a prominent place. This posting is required to be written in bold, legible letters not less than one inch in height. A cash bond made in favor of Rankin County, Mississippi in the amount of \$5,000.00 or 5% of wholesale value of inventory, whichever is greater, must accompany this application. Vendor must maintain a running total of all sales and pay all applicable sales taxes and any other taxes that may apply. Violators of this act or any of the associated ordinances can be convicted of a misdemeanor, fined up to \$500.00 per act and/or imprisoned for up to six (6) months.

I DECLARE UNDER THE PENALTIES OF PERJURY, THAT THIS APPLICATION AND ALL ITS SUPPORTING DOCUMENTATION, IS TO MY KNOWLEDGE TRUE AND CORRECT.
